#### **Purpose**

Funded by the Elizabeth Creak Charitable Trust (ECCT). this high-profile appointment will have expertise in agricultural innovation and a strong awareness of approaches to on-farm technology adoption in the UK and Europe and put in place practical mechanisms to ensure that both the needs of farmers are considered within the context of research and that new research and innovations are appropriately communicated and assisted on-farm when necessary. The position would suit agricultural economist/social scientist with a strong interest in farmer behaviour, change management and taking new innovations to market or an innovation-led agricultural scientist with an interest in on-farm adoption of technology.

### Main duties and responsibilities

The appointed Chair would be expected to build a research group to meet a selection of the following objectives:

- To develop new innovations in the context of one or more areas of the agricultural sciences depending on their expertise
- To work with industrial partners to ensure such innovations reach the market
- To understand the barriers to adoption, the socio-economic and human behavioural constraints on adoption of appropriate technologies by farmers and within farming communities
- To listen to key stakeholders, gathering intelligence on the most urgent needs on farms that technology may be able to address
- To communicate research findings; for instance, enabling farmers to develop and integrate soilsmart and climate-smart systems, allowing farmers to advance by combining technical knowledge with advice using mobile phone technology
- To work directly with farmers and ensure the farmer's voice is fed into research, to ensure successful technology adoption and to identify and work with technology and change champions within the farming community
- To communicate with and influence key decision and policy makers within the UK/EU context.
- To contribute to SAPD educational programmes as appropriate

#### Added Value

Our aim is to ensure the appointed Elizabeth Creak Charitable Trust (ECCT) Chair integrates across the School of Agriculture, Policy and Development to help inform and drive our strategy in relation to innovation, business creation, on-farm extension, technology adoption and knowledge exchange. We would envisage the high-profile appointment would:

This is a full-time post, funded for two years by ECCT. During the initial funded phase, the appointee and associates will initiate an active schedule of applying for research grants in order to expand activities and impact.
